

Annexure to the Memorandum of Understanding For academic exchange and cooperation

Based upon the Memorandum of Understanding (MOU) for academic exchange and Cooperation between College of Computer Science and Information Technology, Latur, and Shikshan Maharshi Dnyandeo Mohekar Mahavidyalaya, Kallam, this annexure pertains to collaboration in teaching and academic programmes.

The Principal College of Computer Science and Information Technology, Latur and Shikshan Maharshi Dnyandeo Mohekar Mahavidyalaya, Kallam, have, therefore mutually agreed to sign this annexure to the MOU.

- 1. This annexure, to the MOU supersedes all previous correspondence and discussions.
- 2. Broad Objectives:
 - I. Provide a common forum for designing and execution of curriculum and collaborative research in the following broad areas, in the first instance,
 - 1. Biotechnology, Bioinformatics and Herbal Technology
 - 2. Biological Sciences
 - 3. Computer Science and Information Technology
 - 4. Mathematical, Statistical & Computational methods
 - 5. Languages & Culture

Use and share libraries, database, documentation and instrumental and related infrastructure facilities.

- III. Exchange information and arrange seminars/workshops.
- 3. Role and responsibilities of College of Computer Science and Information Technology, Latur and Shikshan Maharshi Dnyandeo Mohekar Mahavidyalaya, Kallam
 - i. The Principal, College of Computer Science and Information Technology, Latur and Shikshan Maharshi Dnyandeo Mohekar Mahavidyalaya, Kallam, shall jointly undertake academic and research programmes they are agreed upon by both the parties. The agree to the use of the experimental database generated by both the institutions for the specific research topics to be selected jointly by the facilities of both the institutions on 1:1 basis and the research scholar(s) selected to be paid scholarships as per rules of the University.
 - ii. The Principal, College of Computer Science and Information Technology, Latur and Shikshan Maharshi Dnyandeo Mohekar Mahavidyalaya, Kallam shall provide financial support towards operational cost of journey, experiments, equipments and laboratory facilities if the joint projects are conducted at their institution.
 - iii. The students and staff visiting the institutions shall be provided with Boarding/Guesthouse facilities.
 - iv. Joint working group shall submit projects annually to the Principal, Shikshan Maharshi Dnyandeo Mohekar Mahavidyalaya, Kallam as well as the College of Computer Science and Information Technology, Latur
 - v. The Principal, College of Computer Science and Information Technology, Latur and Shikshan Maharshi Dnyandeo Mohekar Mahavidyalaya, Kallam shall maintain documentary records for performance at seminars, Schemes, Expenditure on schemes, cost sharing and results of research including both successes and failures and shall share these records equitably.
- vi. The Principal, College of Computer Science and Information Technology, Latur and Shikshan Maharshi Dnyandeo Mohekar Mahavidyalaya, Kallam shall make available to each other, free copies of relevant research and other publications. Output for collaborative research activities shall be published under joint authorship.



Senior staff of College of Computer Science and Information Technology, Latur and Shikshan Maharshi Dnyandeo Mohekar Mahavidyalaya, Kallam shall meet at least on a annual bases, preferably in April-May to identify and develop co-operation activities and to determine priorities for the following academic year.

- viii. Specific mechanism for developing or managing activities shall be decided on a caseby-case basis.
- ix. In the implementation of the co-operative activities, each institution shall build on their respective strengths and shall dearly identify the roles in developing and implementing the projects.
- x. The College of Computer Science and Information Technology, Latur and Shikshan Maharshi Dnyandeo Mohekar Mahavidyalaya, Kallam shall assist other in locating funds for approved collaborative activities as well as for developing joint proposals for submission to outside funding Agencies.
- xi. Since neither of the co-operative partners is a funding agency per se, it is therefore, recognized that funds for co-operative projects will have to be raised from a third party Neither party shall hold the other liable, should sufficient funds not become available to cover the running cost of such joint activities Funds raised for a specific purpose of agreed joint activity should be managed and expended to the mutual satisfaction of both the parties.
- xii. Any amendment to this annexure shall be made after consultation and mutual written consent.

4. Confidentiality clauses:

The sharing and dissemination of academic and research information and know-how generated in the course of this collaboration shall be worked out jointly by College of Computer Science and Information Technology, Latur and Shikshan Maharshi Dnyandeo Mohekar Mahavidyalaya, Kallam in keeping with their mutual interest and overall objectivities of this programme.

5. Programme/Project Monitoring Group:

There shall be a Programme/ Project Management Group established at each centre whose composition shall be as follows:

It is principally accepted to form appropriate steering committees (related to specific areas) at the institutions to formulate the research projects and financial aspects related there to, literature and other expenses.

The Programme/Project Monitoring Group shall have a joint meeting at least twice a year alternatively in each institution.

6. Financial Terms and mode of payment if any:

- The requirement of funds for this programme shall be worked out through mutual consent between College of Computer Science and Information Technology, Latur and Shikshan Maharshi Dnyandeo Mohekar Mahavidyalaya, Kallam.
- ii. The Principal, College of Computer Science and Information Technology, Latur and Shikshan Maharshi Dnyandeo Mohekar Mahavidyafaya, Kallam shall not demand any monetary charges from each other for the use of technology and know-how for their own internal use for the purpose of teaching training, research and development
- iii. The Principal, College of Computer Science and Information Technology, Latur and Shikshan Maharshi Dnyandeo Mohekar Mahavidyalaya, Kallam shall work out the modalities for dissemination of research data to any third party. However, both parties shall fulfill their obligation of disseminating the data to national databanks, as required by the concerned funding agencies.

7. Non-exclusive Nature of this MOU:

This MOU between College of Computer Science and Information Technology, Latur and Shikshan Maharshi Dnyandeo Mohekar Mahavidyalaya, Kallam is and shall be non-exclusive in its nature for all parties and shall not come in the way of either partners from collaboration with the third party except as restricted by confidentiality clause.
